Thriving Communities

- <u>About Leadership Education</u> An introduction to the vision and mission of Leadership Education at Duke Divinity
- *Thriving Communities: The Pattern of Church Life Then and Now* by C. Kavin Rowe and L. Gregory Jones. Kavin Rowe takes us into the Acts of the Apostles, the earliest account we have of Christian community. There, we can observe six specific features of the first Christians communities features that we also see wherever powerful Christian communities are gathered today.

SESSION 2

Thriving Communities

• *Living into Community: Cultivating Practices That Sustain Us* by Christine Pohl. Ethicist Christine Pohl examines four core practices that sustain healthy communities and discusses the complications involved when we practice them.

- <u>Why storytelling matters</u> When the church uses storytelling, it becomes a shared space where each person is a part of history, writes a poet and author.
- <u>What is the theological meaning of the city?</u> A theologian urges Christians to understand their own neighborhoods as places that are rich and layered with theological meaning, leading them to think differently about everyday faith and practice.
- <u>On Earth Day, people of faith need to take action on climate change</u> In our current ecological crisis, we must emphasize humanity's role as both stewards and creatures in God's creation, writes a theologian.

- <u>Community Purchasing Alliance helps congregations save thousands</u> CPA offers a self-sustaining model that generates revenue for member congregations and non-profits while helping them further their mission goals and build collaborative relationships. - <u>Care for the land is intimately tied to Black liberation</u> An urban megachurch on Chicago's South Side is a leader in creation care, drawing upon the congregation's history and addressing its current needs.

Transformative Leadership

• *Leadership on the Line: Staying Alive through the Dangers of Leading* by Ronald A. Heifetz and Marty Linsky. This lively and compelling book explores the risks of offering leadership – the kind that may challenge long-held beliefs and surface conflict.
